**TRACT TWO.** the entire width of the right of way of County Road 792 adjoining TRACT ONE.  
**TRACT THREE:** The entire width of the right of way of FM 523, beginning at the intersection of that right of way with the city limits (before this annexation) of the City of Oyster Creek, located at the north bank of the Oyster Creek waterway; Thence, northward along FM 523, to the intersection of FM 523 with the northernmost point of the extraterritorial jurisdiction of the City of Oyster Creek, Texas, more fully described in a Notice of Public Hearing on Annexation posted at City Hall and on the City's website.
